State and federal special education revenues have long been inadequate, and the squeeze from increased need and reduced resources only adds to the necessity for higher General Fund contributions. In light of funding inadequacy, growing compliance demands, increased expectations for improved student outcomes, and anticipated changes to the Assembly Bill 602 Funding Model—local educational agencies must ensure effective program and resource management.
